DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

JOINTLY DEVELOPED

The Lee County High School 9th Grade Campus will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- -The school will hold a meeting before November 1st to gather information from parents and to involve the parents in the planning process for Title 1 programs.
- -The school will hold school council meetings throughout the year to disseminate information and obtain feedback on Title 1 programs and other programs going on in the school. -The school will make positive phone calls home at the beginning of the year to establish relationships with parents.

ANNUAL TITLE I MEETING

-After parent input and revisions, the school will hold a meeting on September 29th at 5:30 PM to discuss the nature of the Title 1 program. The parents will be informed of their requirements to

-The parents will have an opportunity to review the school improvement plan and discuss how Title 1 programs fit into the school improvement plan.

COMMUNICATIONS

Lee County High School 9th Grade Campus will take the following actions to provide parents of participating children the following:

- -The school will hold an annual Title 1 night on October 18th at 5:30 pm to disseminate school-parent compacts, parent engagement policies, and parent rights.
- -The school-parent compact and the parent engagement policy will be sent home with each student served through Title 1 programs.
- -Parents are invited to join the parent teacher organization.
- -Parents are invited to join our school council organization, which meets quarterly.
- -Information will be disseminated to parents with an opportunity for the parent to use a platform like Google translate, ParentSquare or a school translator to put information into a language that is understandable.
- -Students enrolled from The Bridge, will receive correspondences and invitations to parental/family involvement activities. This will be sent to the facility.

SCHOOL-PARENT COMPACT

Lee County High School 9th Grade Campus will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

- The parents, students and faculty partnered together to develop the compact for achievement. Teachers suggested home learning strategies, parents gave input on the types of support they needed, and students told us what would help them learn. Parents are invited to attend revision meetings in the spring and to make suggestions on surveys throughout the year based on student needs and school improvement goals.
- -The school will hold an information session before November 1st to let parents know about Title 1 programs and dates of upcoming events. The school-parent compact will be discussed. -The school will hold an annual Title 1 night on October 18th at 5:30 pm to gain input and develop a school-parent compact.

RESERVATION OF FUNDS

Lee County High School 9th Grade Campus will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by:

-The budget for the 1% of Title 1 funds reserved for parent and family engagement will be discussed during the informational session before November 1st and during the Title 1 night.
-Throughout the year through surveys and family engagement events, parents will have the opportunity to present ideas to get other parents and families involved. The parents will have the opportunity to discuss how they would like the money spent.

COORDINATION OF SERVICES

BUILDING CAPACITY OF PARENTS

Lee County High School 9th Grade Campus will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership

among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

- -The school will hold an open house with break out sessions to cover topics such as academic standards, assessments, how to monitor their child's progress, and how to improve their child's achievement.
- -The school holds parent meetings to help monitor the progress of the child throughout the year.
- -The school will meet with parents before the school year to address the curriculum and develop an academic plan for high school.
- -The school will invite parents to join the parent teacher organization and the school council to ensure the parents are aware of the activities going on throughout the year.
- -The school will provide opportunities for members of the community to come in and speak to the students.
- -The school will disseminate information and resources through parent and community newsletters, ParentSquare, social media, open house, parent emails, parent-teacher conferences, parent portal
- -The school will host family curriculum nights, conduct campus tours, and make positive contacts to the homes of students.

BUILDING CAPACITY OF SCHOOL STAFF

Lee County High School 9th Grade Campus will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the

assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- -The school will assist teachers and other support staff with training on how to reach out to and build relationships with parents and members of the community. This will occur at least twice per semester.
- -Topics will include: the value and utility of parents, how to reach out and communicate with and work with parents as equal partners, coordinate parent programs/activities which build ties between home and school, provide information in a language that all parents can easily understand, and respond to parent requests for family and parent engagement activities.
- -The school will create a school council to educate parents and members of the community on items related to Title 1 programs.
- -Throughout the year, we will ask for parent assistance and input as to how best to work and train our teachers to work with parents as equal partners.
